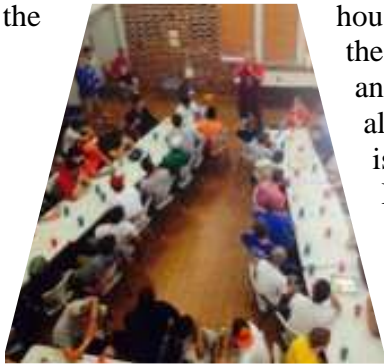


Active Chapter Report– Jesse Birkenholz Chapter Prytanis, 1612

Alumni Profile - Dennis A. Watters - 284



Frater Dennis Watters was born in October 9, 1941 and grew up in Lake City, Iowa where his family owned and operated a retail business. Dennis and his brothers gained valuable

business experiences while working at the family store during high school. Dennis and his younger brother Rollie - 285, followed their older brother's (Reginald - 75) footsteps, and enrolled at NWMSC and in the spring of 1962 pledged Delta Nu.

While a pledge, Dennis and Rollie were well known for their amazing musical talents. On one occasion the two brothers along with a couple other pledges, marched into the Student Union, (known as the 'Den' in those days) playing some rocking music to support TEKES campaigning for student government offices. (We won of course.)

A fond memory for Dennis and the more than 50



pledge brothers was the "Pledge Skip" to Oklahoma State University in Stillwater, OK. That had to be quite a sight with Pledge Trainer Ron 'Bubbles'

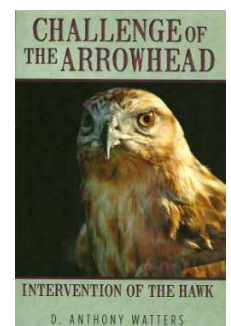
Zimmerman leading a caravan of a dozen cars down the highway and even make it back without losing anyone. Another event that stands out was the preparations for homecoming the following fall. Two all-nighters working on the TKE float proved to be a good time and being able to work with a lot of great young men at the same time was an excellent experience. He did, however, develop a dislike for chicken wire and white napkins. We may have won float that year, but either way it was a great float.

Dennis married his long time girl friend from high school in 1964 and moved to Minneapolis until 1971, after which he rejoined father and brothers in a new family business venture in Lake City. His wife

Sheryl passed away in 1992. A couple years later he met and married Bonnie and in 1994 moved to Iowa City where he worked as an insurance agent. At this time Dennis decided he wanted to complete his college degree and began taking classes in Jazz Performance at Kirkwood Community College in Cedar Rapids and later on to the University of Iowa to take classes in Fiction Writing.

In 1999, Bonnie and Dennis decided to fulfill his life-long dream of owning and producing his own Big Band. To help support this dream and still have time to plan and perform, Dennis took a position with the Iowa City Community School District as a Detention room supervisor at a local Jr. High, a job I could do while maintaining the band. They performed with their "D. Anthony Swing Street Band" from 2000 until he had to quit for health related reasons in 2012. After retiring from the work force he decided to devote his retirement to a new career as a fiction author. Now he and Bonnie are having a great time writing and publishing. They finished their first novel (Challenge of the Arrowhead) in 2013 and published it in 2014. At present they are working on several other works, one of which is a sequel to Challenge of the Arrowhead. They hope to publish their next book yet this year or early next year. Of course gifts can be given anytime through the nwtke.com web site or through the Northwest Foundation.

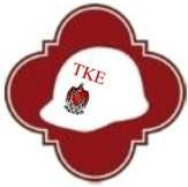

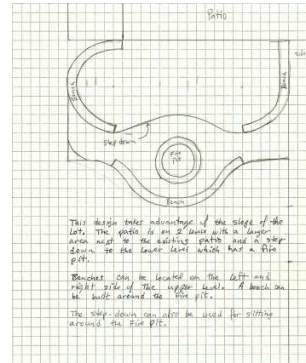
Capital Improvements Fund 2014 Update - Keith Jorgensen, 438
