## GRAND BAHAMA CONCLAVE

Don't forget the 34th Teke Conclave at the Jack Tar Hotel, West End, Grand Bahama Island, August 29 - September 2, 1967. Registration fee (includes room, breakfast, lunch, dinner and gratuities for 5 full days) is \$115 for all non-voting adults. For children under 12 in the same room with parents, it's \$8.50 per day.

Hotel reservations should be made through the TKE Central Office, 3755 Washington Boulevard, Indianapolis, Indiana 46205.

You can travel the M.S. Grand Bahama from West Palm Beach, Fla., to West End or fly Eastern Airlines. The round trip cost for each is \$22.50. The limit on the boat is 225 people so make your reservation early by writing 158 Port Road, Port of Palm Beach, Riviera Beach, Fla.

You may be able to fly directly from your home to West End, Grand Bahama. Check with Eastern Airlines.

Bring the family as the facilities at the Hotel are excellent and there is plenty to do -- 57 1/2 things, in fact. For registration forms and answers to questions, contact the Alumni Director at the Central Office. You can arrive early or stay late and still take advantage of the Conclave rates.

Gamma-Delta Chapter at the University of Miami, Miami, Florida, was reactivated in November, 1966.

New Chapters Installed

Four new chapters have been chartered to date this year. They are: 1). City College of New York, New York City, 15,300 students, 24 fraternities; 2). University of Arizona, Tucson, Arizona, 22,100 students, 29 fraternities; 3). Villanova University, Philadelphia, Pennsylvania, 4,500 students, 4 fraternities; and 4). Wisconsin State University, Oshkosh, Wisconsin, 8,200 students, 7 fraternities.
